6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 on 2078/07/07 (24th OCT 2021) at the Jaljala Rural Municipality. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the bid validity period. The scanned copy of bid security, company/firm registration, renewal, and tax clearance certificate should be uploaded at the time of bid submission
