### Invitation for Bids for the Construction of 10 Bed Primary Hospitals at JRM-03, Mallaj

1. The Government of Nepal [GoN] *has allocated funds* towards the cost of **Construction of 10 Bed Primary Hospital at JRM-03, Mallaj** and intends to apply part of the funds to cover eligible payments under the Contract *for Construction of 10 Bed Primary Hospital at JRM-03, Mallaj, JRM/NCB/W/12/2077-78*. Bidding is open to all eligible as per Section V of bidding document..
2. **Jaljala Rural Municipality** invites electronic bids from eligible bidders for the **Construction of 10 Bed Primary Hospital at JRM-03, Mallaj**, under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **Nrs 70.5 Million**
  - Minimum Work experience of similar size and nature :- atleast one building work of minimum value **Nrs 76.0 million**.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Bidders should deposit the cost of bidding document of Nrs 10000.00 (Ten thousand rupees only) in the office revenue account as specified below and the scanned copy(pdf format) of the bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

7. Pre-bid meeting shall be held at Rural Municipality Executive, Jaljala Rural Municipality, Parbat at 14:00 on 2078/02/04 (18th May 2021)
8. Electronic bids ( one technical and another price bid) must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) or before 12:00 hrs on 2078/02/14 (28<sup>th</sup> may 2021) Bids received after this deadline will be rejected.
9. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 2078/2/14(28<sup>th</sup> may 2021) at the office of Jaljala Rural Municipality, Parbat Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Nrs 2.90 million** which shall be valid for 30 days beyond the validity period of the bid
10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
